備註 Note:

- 一、畢業至少應修 35 學分，必修 17 學分（含論文 6 學分），選修 18 學分（專業選修至少 12 學分）。  
Before graduation, each student should complete at least 35 credits, includes 17 required credits (Thesis 6) and 18 elective credits (at least 12 credits should be completed in department elective courses)
- 二、本碩士班訂有畢業門檻，研究生必須於畢業前考取一張本碩士班訂定之核心證照，且 TOEIC 成績達 550 分以上（或同等之其他英文語言能力測驗、或修習本碩士班認定本校所開設之英文相關課程 3 學分且成績需達 70 分以上），始可畢業。  
To meet the graduation requirement, students are required to obtain one core certificate/license approved by the program. In addition, students are required to pass the English proficiency test (minimum of TOEIC 550 or equivalent) or complete 3 credit hours of English related courses approved by the graduate program with a minimum 70 points passing grade.
- 三、學生應於申請學位考試前至「教育部臺灣學術倫理教育資源中心」網路平臺完成學術研究倫理教育課程，至少 6 小時課程。  
Students need to complete the academic research ethics education course for at least 6 hours before the final defence application.
- 四、大學（專）時未曾修習管理學或健康管理等相關課程，應至大學部補修任一門，且及格標準分數為 70 分，但不列入畢業學分內。  
If the student has not taken courses related to Management or Management of Health Management during his or her Bachelor program, the student is required to retake a course in the undergraduate program with the passing score at 70. Note that the course will not be counted in the graduate degree plan course.
- 五、相關畢業門檻之規定依健康產業科技研發與管理系碩士班研究生修業規則辦理。  
Related provisions of graduate credits shall proceed in accordance with Regulations Governing Master's Department of Healthcare Industry Technology Development and Management.
- 六、115 學年度入學適用。  
The regulation shall be applied starting 2026.
- 七、為因應法規變更、評鑑建議或政府計畫規定等外在因素，本系保有調整學分計畫之權利。若有修訂，將於學期開始前公告，並明確說明修訂內容、影響範圍及相關配套措施，以保障學生權益。
